**MINUTES**

**District Indemnity Sub Committee Meeting**

**Date: 29<sup>th</sup> March' 2022 from 2:00 P.M onwards**

A Family planning District Indemnity Sub Committee Meeting was held on 29<sup>th</sup> March' 2022 from 2:00 P.M onwards at Office Chamber of Joint Director of Health Services, Darrang under the chairmanship of Addl. Deputy Commissioner (Health), Darrang in presence of Joint Director of Health Services, Addl. CM&HO (FW), LS Surgeon, Dy. DEMO, SI (FW), DPM and DFPC.

As per agenda various issues of Family Planning activities were discussed.

**During this meeting following points were discussed:**

1. Addl. Deputy Commissioner (Health), Darrang chaired the meeting and welcomed all the present Officials and Members of District Indemnity Subcommittee.
2. Addl. Chief Medical & Health Officer (FW), Darrang discussed briefly the objective of the meeting and also discussed the resolution of previous meeting.
3. DFPC, NHM, Darrang bring to knowledge of the house about the performance of Family Planning (April 2021 to February 2022). He raise the issue of NSV surgeon as the trained NSV Surgeons are transferred to other district.
4. The LS Surgeon of Mangaldai Civil Hospital raise the issue of trained LS Staff Nurse. Because the trained LS Staff Nurse of Mangaldai Civil Hospital will be retired on 31<sup>st</sup> March' 2022.
5. DPM, NHM, Darrang discussed about the performance of Family Planning, especially in permanent method. She asked to DFPC to arrange a district level review meeting on Family Planning in the month of April' 2022.
6. Joint Director of Health Services, Darrang discussed about the gaps found in Family Planning services during his monitoring visit. He advised to District and Block level officials to monitor the FP activities at field level. He asked to Addl. CM&HO (FW) and DFPC to fixed the BPHC wise target of family planning activities for the FY 2022-23 by April 2022. So that District target should be achieved by the end of the financial year.

7. Addl. Deputy Commissioner (Health), Darrang asked to all to gear up the performance of Family Planning both permanent and temporary method. She asked to District level Officers/ Officials to monitor the Family Planning activities at Block level as well as at field level.

**Some Resolution were taken at the end of meeting after all discussion:**

- Letter has to be sent to MD, NHM, Assam for arranging of NSV training for Medical Officer (Surgeon). Action- Addl. CM&HO (FW).
- Letter has been sent to MD, NHM, Assam for arranging of LS training for Staff Nurse of Mangaldai Civil Hospital. In this context, follow up has to be done with NHM State HQ. Action- DFPC.
- District level Family Planning review meeting has to be conducted in the month of April 2022. Action- Addl. CM&HO (FW)/ DFPC.
- BPHC wise Family Planning target for the FY 2022-23 has to be fixed in the month of April 2022. Action-Addl. CM&HO (FW)/ DFPC.
- The District level Officers/ Officials, DQAC and DISC members will monitor the BPHC, Health Facilities periodically and also will monitor the LS & NSV Fixed Day Services for quality of Family Planning services. Action- DQAC & DISC members.
