

4. As discussed 6 Nos of Female FDS (Fixed day Static) has been scheduled for the month of December at entire Dhemaji District and it is also discussed to ensure the quality at every level during the Camps.
5. The house decided to arrange ASHA & ASHA Supervisors review cum orientation at BPHC level regarding the compensation of Family planning activities and new family planning methods
