- The Rafiqui Islam, District Family Planning Coordinator, NHM, Dhubri explained the aims and objectives of the meeting,
- 2) The DFPC presented a PPT of quarterly performance of FP services in the meeting.
- The District Family Planning Coordinator informed the house about the empanelled Doctors for performing Lap. & NSV Sterilization.
- 4) The Jt. DHS stressed on the preoperative investigations which need to be done on time to avoid any untoward complicacy.
- 5) The Joint Director of Health Services cum Member Secretary, DHS, Dhubri instructed the DFPC to look into that the fixed day static FP service at Civil Hospital, Dhubri and asked DFPC to increase the number of cases in convergence with BPHCs of Dhubri.
- 6) The Preoperative and postoperative counseling to the beneficiaries of family planning is required to provide on time which would minimize the complexity as well as make the program successful. Such as the benefits or knowledge of Antara Injection are required to explain during preoperative counseling.
- 7) The meeting informed the house that approach of service providers to clients is not amiable as result beneficiaries feel reluctant to avail services from them. Therefore, he stressed that good approach is also a part of quality assurance and service providers should behave friendly with the beneficiaries and also counseling all related sterilization message for better quality performance.
- 8) The Block pharmacists are asked to maintain the stocks and to monitor the stock status of the respective periphery. On the other hand, DDSM would monitor the stock status of each block so that beneficiary may choose the best method of Family Planning and FPLMIS can implement or Operational upto Asha level.

The meeting ended with vote of thanks from the chair.
