

Minutes of the meeting of District Indemnity Sub-committee (2nd Quarter 2021-22)

The meeting started with welcome address by the Joint Director of Health Services, Karimganj.

The following points have been discussed and decisions have been taken:

1. Analysis of FP Performance: The committee analysed the FP performance comparing with the performance of the last year and decided that the District Hospital should put maximum efforts to gear up performance.


2 .Discussion on MPV Fortnight: The committee is appraised about the WPD/MPV performance of 2021. It is pointed that in the MPV Fortnight, 14 LS camps have been scheduled out of which 12 camps have been conducted in which total 315 LS cases have been done. But as there is less number of LS Surgeons in the district, all the camps could not be completed within stipulated fortnight period. Hence the performance could not be included in the WPD/MPV Fortnight. The committee expressed satisfaction with the performance and desired that this frequency and sustainability should be maintained.

3. Accreditation of PPIUCD Service Providers from various institutions: The committee is appraised about the PPIUCD trainings conducted and institutions which are performing. A list of nominated PPIUCD service providers have been produced before the committee. It has been decided that only the names of performing service providers be accredited. It has also been observed that in the DH, performance of PPIUCD is not at all satisfactory and the committee requested the Gynecologists of Civil Hospital to gear up PPIUCD performance. The committee viewed seriously about the non performers and it is decided that those who are not performing may be requested to gear up PPIUCD performance.

4. FPLMIS: The committee is appraised about the FPMIS status. It is brought to the notice of the committee that though at district and BPHC/PHC level HIs are operationalised, the SCs and ASHAs are yet non-functional. FP contraceptive distribution is an integral part of FP activities, it is urged that this aspect should also be given equal importance by all health workers especially by ASHAs & the S.D.M. & H.Os/In-charge of concerned/respective health institutions should keep a close monitoring of the functioning of FPLMIS.

5. Scrutiny of Failure Cases: There is no LS failure cases to be scrutinized. But The cases already submitted are yet to be cleared from the state. The committee urged that the matter be pursued wit the higher authorities.
