The NSV performance of the district is not satisfactory. The FDS scheduled at Bihpuria, Dhalpur, Dhakuakhana, Ghilamora and Boginodi are due to no mobilization and no availability of clients.

2. The PPIUCD performance of the district is only 18% against the total delivery-BPHC wise PPIUCD performance-

The ADC, Health, directed all in charges to gear up the performance by instructing all trained providers.
