- Dr. Altaf Ahmed, Joint Director of Health services, Tinsukia in his inaugural speech gave a brief and concrete overview of District Quality Assurance Committee (DQAC) and Dist Family Planning Sub-Committee (DISC).
- It is to be ensured that all the FP service provider have to be empanelled list of DISC committee in a regular interval.
- Updating of Empanelment of all family planning service delivery categories was done by Joint Director of Health services, Tinsukia and accordingly a notification will issued.
- It is noted that last two qtr sterilization (both LTO & NSV) not been done due to Covid pandemic situation. So Jt. DHS suggested that LTO and NSV operations have been done with proper maintaining of Covid protocol (viz., RAT test of beneficiary, social distancing etc.)
- Family planning coordinator has been updated the both LTO and NSV operations being done during World Vasectomy Day (WVD).

- Jt. DHS urge to all to promote Inj. Antra (MPA) in Tinsukia Civil Hospital as well as the PHC, CHC level and accordingly suggest to complete the Inj. Contraceptive to SC level for rolled out.
- Moreover to promote Chhaya tablet as a better method of contraception for family planning activities where its circulation is comparatively low as compared to the years.
- An overview of total performance, failure, complications, death and claim has been discussed by the Joint Director of Health services, Tinsukia.
- The meeting was ended with vote of thanks for the chair.
