**Sub: Regarding Operational guideline for Charitable Hospitals under PPP for the year 2020-21**

Sir /Madam,

With reference to the subject cited above, I am to inform you that Govt. of India has accorded approval of 5 numbers of Charitable hospitals to be included under PPP with NHM, Assam under the FMR Code-15.9.7 for the year 2020-21. In this regard district wise physical & financial allocation along with Operational Guidelines has been prepared based on RoP approval. You are, therefore, requested to sign the MoU with concern hospital management authority after reviewing the performance of previous year and to be implemented as per guideline enclosed.

On signing of the agreement, the district authority may release the 50% amount to the concern hospital as approved in the RoP 2020-21 from the available fund with District Health Society account subject to the necessary adjustment of previous year's balance and receiving the UC and SoE. Districts should strictly follow all the financial norms and guidelines for implementation of the aforesaid activity.

It is also requested not to make any changes in the allocation of the activity without approval of the undersigned. The owner of the activity has been indicated in the guideline. He /She will be responsible for implementation of the activity.

You are, therefore, requested to circulate the operational guideline for implementation of the activity at the earliest to all concern.
