- An overview of total Male & female Sterilization performance has been discussed by the Joint Director of health services, Jorhat with all members .
- Jt. Director of Health service, Jorhat adviced to i/c DFPC and i/c SI for prepairing a Microplan of FD Camp & Special camp of Family planning and instructed to circulate the Microplan with SDM & HO and BPMU.
