At the onset of the meeting, the Joint Director of Health Services has welcomed all the committee members of the meeting and explains the objectives of the meeting.

During the meeting, the following points have been discussed and taken note accordingly.

1. It is decided to give more emphasize on Fixed Day Static (FDS) LS at Dhirenpara FRU & Sonapur DH where LS Surgeon available.
2. The House suggested that Hep-B, Hep-C & HIV tests are mandatory for each cases of Laparoscopic Sterilization, the tests are to be made available free of cost. Also advised Skin test mandatory before administering local anesthesia. Any Sterilization case, Anaesthetist must be present during sterilization.
3. The house agreed to rationalize the LS machine set from Pandu FRU to DH, Sonapur to start Laparoscopic Sterilization services.
4. To ensure quality service delivery of Laparoscopic Sterilization, the committee decided to place requirement for 3 additional no.s of Laparoscopic Sterilization Machine sets to the MD, NHM, Assam. It is discussed that during the sterilization process, the Laparoscopic Sterilization Machine set needs to be sterilized at minimum 30 minutes for each case.


