The meeting started with welcome address by the Joint Director of Health Services, Karimganj.

The following points have been discussed and the decisions have been taken:

1. **Analysis of FP Performance:** The committee analysed the FP performance of the last comparing with the performance of the last year and decided that the District Hospital should put maximum efforts to gear up performance.
2. **Discussion on World Vasectomy Fortnight:** The committee have been appraised about the ensuing World Vasectomy Fortnight. An action plan have been shared wherein all the BPHCs have been given ELA as per state guidelines. It has been decided that as there is no NSV surgeon in the district, the Jt. DHS have been requested contact SMCH and arrange for NSV Surgeon. It is also resolved that on 28<sup>th</sup> Nov, a centrally organized NSV camp will be conducted at the district hospital and all the BPHCs are to send their beneficiaries at the DH on the camp date.
3. **Enlisting of Eligible Couples for various FP methods:** The committee decided that all the BPHCs be strictly advised to adhere to the state guideline for filling of CNA format and prior to the camps the list of Eligible couples should be sent to the district.
4. **Accreditation of PPIUCD Service Providers from various institutions:** The committee is appraised about the PPIUCD trainings conducted and institutions which are performing. A list of nominated PPIUCD service providers have been produced before the committee. It has been decided that only the names of performing service providers be accredited. It has also been observed that in the DH, performance of PPIUCD is not at all satisfactory and the committee requested the Gynecologists of Civil Hospital to gear up PPIUCD performance. The committee viewed seriously about the non performers and it is decided that those who are not performing may be requested to gear up PPIUCD performance.


