2. The house discusses and resolves to emphasize on updating of EC Register through ASHAs for four times a year for they will be provided incentives for the same. Thus it is resolved to disseminate the guidelines to all HIs/Block PHCs under the district for smooth functioning the MPV programme in the district.
3. The house discusses and reviews on FP-LMIS and thus resolves to continue with online indenting process for the contraceptives to ASHA level for reporting systematically on Family Planning Activities every month in the district.
4. The house discusses on the quality of FP services and thus resolves to ensure the quality services during Fixed Day Services, Tuesday and Friday at RNB-CH,



- Kokrajhar/Gossaigaon by giving training and sending for ToT in the state for more number of service providers and checking facilities and ensuring necessary pathological tests before hand.
5. The house discusses on the training programs to be conducted under the Family Planning activities as per the guidelines and RoP approved, for the FY 2022-23 and thus resolves to carry out within a stipulated date and time..
 6. The house discusses regarding IUCD/PPIUCD/PAICD services performed in the BPHCs and resolves to ensure the quality of services by visiting 4 times a month in all BPHCs from the district level team.
 7. It is also discussed and thus resolved to mobilize NSV beneficiaries by paying extra visit in unreached area like Lungsung, Saralpara, Raimona, Mornai TE etc. for gearing up the male participation in the FP program.
 8. It is discussed and thus resolved to send the daily report to the state headquarter and also to send any Failure cases report found in the district to the state head quarter on behalf of clients to who is concerned for the benefit of the same.
 9. The house discusses on Death, Complication and any Failure arising out of Sterilizations/IUCD/PPIUCD/PAIUCD/Antara and thus resolved to submit documents as report to the higher authority, State Headquarter, Assam.
 10. Lastly the house discusses on the quantity, the number of cases load Health Institution-wise regarding adoption of Family Planning methods and thus resolved to rationalize with the number of load of delivery in each HI to see how improvement of quality of services is taking place.
