Heard Mr. G. N. Sahewalla, learne'd Sr. Counsel assisted by Mr. A. Chetia, learned counsel for the petitioner.

In this writ petition, petitioner has assailed the debarment notice dated 24.07.2018 debarring the petitioner from participating in any tender of Govt. of Assam and National Health Mission (NHM) for 5 years; further directing the petitioner to withdraw all unconsumed drugs from the districts as well as drug stores of medical colleges.

Mr. Sahewalla, learned Sr. Counsel submits that aforesaid notice was in connection with the tender notice dated 11.11.2014. Petitioner was not a tenderer in the said tender process. Respondent No. 4 was a tenderer and he was awarded supply orders for supply of medicines. Respondent No. 4 had purchased some quantity of medicines from the petitioner but there is no contract agreement between petitioner and NHM. Thus, NHM could not have debarred or disqualified the petitioner. Impugned notice is therefore without jurisdiction.

Issue notice, returnable 8 (eight) weeks.

Mr. D. P. Borah, learned Standing Counsel, Health Department accepts notice on behalf of respondent No. 1 whereas Ms. A. Bora, learned Standing Counsel, NHM accepts notice on behalf of respondent Nos. 2 & 3.
