## Minutes of District Indemnity Sub-committee (DISC) Meeting

District Indemnity Sub-Committee (DISC), Goalpara Meeting held on 28<sup>th</sup> December 2018 at Office of the Addl. Chief Medical and Health Officer under the chairmanship of Additional Chief Medical and Health Officer (FW), District Immunization Officer, DFWB, Two Empanelled Laparoscopic Surgeon, Two Empanelled NSV Surgeon, other three members from DQAC, and all the Block Programme Manager.

### **The following points were discussed during the meeting:**

1. The Addl. Chief Medical & Health officer(FW) informed the house that during World Vasectomy Fortnight 2018 only Goalpara Urban and Mornoi BPHC has achieved their ELA and others BPHC did not achieved their ELA given by District Health Society.  
  
In this regard chairman directed to DFPC to issue a show cause notice to all low performing BPHC.
2. The Addl. Chief Medical & Health officer (FW) also reviewed all the facilities performances where CCC training has been done by IPAS officials.
3. During the meeting Addl. Chief Medical & Health officer (FW) has formed a District level Family planning monitoring Group in connection of monthly review all the Family Planning Activities through block level.
4. The Addl. Chief Medical & Health Officer (FW) instructed to DFPC that all approved Family Planning training & orientation need to be completed as per guidelines and need to be maintained the quality.
5. The Addl. Chief Medical & Health Officer (FW) also instructed to DFPC to prepare a activity wise service provider list so that the District level Family Planning monitoring group can easily review all the low performing sector.
6. As requested by Block Programme Manager Lakhipur & Agia BPHC, the Addl. Chief Medical & Health Officer (FW) instructed to DFPC to nominate one Medical Officer from Boat Clinic and MMU for Injectable Contraceptive training for proper implementation of Antara Programme.
7. The Addl. Chief Medical & Health Officer (FW) instructed to DFPC to issue a letter to Superintendent, 200 Bedded Goalpara Civil Hospital, SDM & HO of Agia BPHC, In- Charge of Maternity and Child Health Centre, Joypur MPHC, Kharmuja MPHC, and Joleswar MPHC regarding Jhpiego's technical Support in Family Planning Services for improvement of Family Planning performances.
