After the greetings from Jt.DHS, Kokrajhar the Following agenda on Family Planning have been discussed and resolved:



2. The house discusses on the poor performance of Laparoscopic Sterilization during the last three months and resolves to conduct the same on the basis of FDS and SDS with the new machine brought from Dhubri district.

5. The house discusses about the last failure/death report sent to the higher authority in which some of beneficiaries from our district had to receive compensation. Thus the house resolves to remind the state authority for favour of kind information and necessary action.
6. The house discusses on the Family Planning movement in the district in harmony with districts, state and the country at large. Thus the house resolves to keep the supply of uninterrupted contraceptives to the door steps by means of HDC by ASHAs.
7. The house discusses on visiting, monitoring and evaluation at the ASHA level regarding Family Planning performance and thus house resolves to assign target to ASHAs for any of the FP method adoptions as per the number of EC in the village.
