Today a meeting of District Quality Assurance Committee was held under the Chairmanship of the i/c, Joint Director of Health Services. The Supt. of JSB Civil Hospital, SDM&HO, HQ, the DIO i/c, Chirang, Empanelled O&G Specialist Dr. Eyakub Ali Ahmed, Empanelled Surgeon Dr. P.N. Brahma, DPM Sonatan Isawary, Mr. Gautam Mahilary, HA, JSB-CH, Mr. Palash Ch Roy, DFPC, NHM, Chirang were present in the meeting. During the meeting the house discussed the various points for upliftment of hospital facilities as per agenda and following resolutions have been adopted unanimously by the house:-


- 1) The house dicided to implement Kayakalp and Quality assurance properly in all the health facilities under Chirang District. The Incharge & along with HA/BPM/ABPM of the concern hospital is complete responsibility for implenating the program.
- 2) The house decided to fill up the gaps idintified during internal Assessment of health facilities & the gap filling activities will be carried out by utilizing fund allocated for Kayakalp and Quality assurance, if necessary RKS fund will be utilized for that purpose also.
- 3) The house decided that all the facilities must give orientation training of Kayakalp & Quality Assurance to all the staff.
- 4) The house decided that all the concern hospital will install Cattle trap, Rain Water Harvesting, Compost Pit, general/Herbal Garden as per gap assessment. The HA/DME/AE Civil) will guide in this regards.

- 5) The house decided that DPMU will visit the concern hospital to guide and support to the concern hospital.
- 6) The house directed the HA of JSB Civil Hospital to carry out Internal Assessment of JSB Civil Hospital and Bhetagaon CHC under NQAS.
- 7) Dr. D. Ramciary, i/c, Jt. DHS cum Member Secretary, Chirang explained aim and objective of the meeting, which is to improve the performance family planning services in Chirang District.
- 8) The role of District Quality Assurance Committee (DQAC) was discussed. In this meeting all the members emphasized to improve and maintain the quality of family planning activities, especially on male & female sterilization
- 9) The house decided that all the facilities MO/Nurse must give training of Family Planning services.
- 10) In order to maintain quality in the service it is recommended that fixed day service should be started in place of camp for Male & Female Sterilization at JSB Civil Hospital and Bhetagaon CHC.
- 11) To engage MPW's for better patient care, especially NSV beneficiary.


