

- direction from the beginning of FY-2019-20 as per the Action Plan developed.
2. The house discusses on Family Planning services and thus resolves to strengthen by encouraging and involving more people, departments (Convergent), NGOs, community organizations etc. throughout the year.
 3. The house discusses on empanelment of surgeons, MOs, Staff Nurses and ANMs in different Family Planning Activities for permanent and temporary methods as previous year 2018-19.
 4. The house discusses on SGL (Spacing, Gap and Limiting) of Family Planning and thus resolves to gear up the same for reaching every door step by means of HDC, clear message FP to community and counseling by ASHAs.
 5. The house discusses on visiting during Fixed Day Services, monitoring during the VHNDs and evaluation after the interaction at the ASHA level regarding Family Planning performance and thus house resolves to do the same accordingly.
 6. The house discusses on Training done in few last years and trained persons (MOs, SNs, ANM and Pharmacists) for FP activities will be directed to gear up of the same.
