- Line listing of category wise family planning services (LS, NSV, IUCD, OCP, CC, Inj. Antara, Chhaya) for block PHC and sector wise.
- Jt. DHS urge to all to promote Inj. Antra (MPA) in Tinsukia Civil Hospital as well as the PHC, CHC level and accordingly suggest to complete the Inj. Contraceptive to SC level for rolled out.
- Under Tinsukia Dist all delivery point were identified and promote PPIUCD, PAIUCD, and IUCD at the utmost.

- The resolution has to be taken that the PPIUCD train provider has to get a badge so that beneficiary known easily for insertion.
- FP coordinator updated the status of achievement to received a reward for State NHM for both Male and Female sterilization.
- An overview of total performance, failure, complications, death and claim has been discussed by the Joint Director of Health services, Tinsukia.
