# Minutes of the Meeting On State Indemnity Sub-Committee Meeting of Family Planning held on 19th August '2020 at Conference Hall, NHM, Assam

The State Indemnity Sub-Committee Meeting was held on 25th of August, 2020, under the chairmanship of Mission Director, NHM Assam. At the outset, the chairman welcomed all the members and requested the house to initiate the discussion as per agenda.

## The following discussions were done during the meeting:

- > The chairman instructed the SISC convener to ensure that SISC meeting are held on regular basis (6 monthly). Further all Addl. CM&HO should also be instructed at the district level to do regular DISC meetings (Quarterly).
- > The total number of failure cases reported in the state for the last three financial years and their claim status were reviewed. It was seen that in the financial year 2017-18 total of eighty (80) claims were submitted from the district. Out of which three (3) were death cases, seventy six (76) failures and one (1) complication. In the year 2018-19, total of eighty one (81) claims were submitted from which seventy four (74) were failure and one (1) death. In the year 2019-20 total claims submitted was eighty two (82) out of which seventy six (76) were failure and three (3) deaths.
- > It was also seen that the total number of compensation claims have increased in the financial year 2019-20.

- > During the discussion it was found that right selection of the cases was one of the major issues resulting in increase in the failure rates. Further it was insisted by the house that the process of selection of the beneficiaries should be done more meticulously.
- > The Chairman instructed that the Surgeons who have experienced more sterilization failure rates needed to be notified.
- The Chairman also insisted that the failure cases which come out to be genuine after the scrutiny should receive the compensation as per guidelines in a smooth manner.
- Quality of sterilization services should be monitored by District officials, led by Addl.CM&HO and DFPC so that all the processes starting from registration, counseling and screening of the beneficiaries are done as per protocol and in timely manner. The chairman also mentioned that a training needs assessment may be done of the empanelled surgeons and if felt needing trainings, may be trained again.
- Further the chairman also instructed that the list of all the failure cases should be sent to the respective districts surgeon wise and a self-review has to be done by the surgeons so that failures can be minimized.
