ORDER

Where as a short tender notice was floated for printing and supply of “Mother and Child Protection (MCP) Cards vide no. NHM/1018/6/2018-Maternal Health/7909 dated 14/07/2022 in light of special immunization drive by NHM, Assam for which MCP Cards were urgently required.

Where as MCP cards are issued to every pregnant women and children for registration and tracking of services including immunization, without the MCP card, Ante Natal Care and immunization services cannot be recorded.

Where as considering the importance and urgency, the tender was floated indicating certain clauses and fixed timelines and conditions for supply.

Where as rate quoted by M/S Priyanka Printers became L1 rate and selected as vendor.

Where as work order issued in favour of vide order no NHM/1018/6/2018-Maternal Health/182 date 26/09/2022.

And where as M/S Priyanka Printers informed the office of the undersigned their inability to execute the work vide letter dated 29/09/2022.

Where as a showcase notice vide this letter no. NHM/1018/6/2018-Maternal Health/20175 dated 28/11/2022 was served to Priyanka Printers for violation of Tender condition and asked them to reply to the undersigned within 30th November 2022 and no reply received in response to this office show cause notice.

Where as requirement of MCP card was urgent and without which public interest hampered.

Now in view of the above, considering the suffer to public interest due to non-execution of printing works, violation of terms and condition, EMD/bid security furnished by M/S Priyanka Printers is hereby forfeited and the firm is debarred from participating in the tender process under NHM, Assam for five years w.e.f date of issue of this order.
