Preface

National Leprosy Eradication Programme (NLEP), India is a Centrally Sponsored Scheme under the umbrella of National Health Mission (NHM). The primary goal of the Programme is to detect the leprosy cases at an early stage and to provide complete treatment at free of cost, in order to prevent the occurrence of disabilities in the persons affected and stop the transmission of disease at the community level. The Programme also aims to spread awareness about the disease and reduce stigma attached with the disease.

Assam has achieved the goal of elimination of Leprosy (i.e. Prevalence Rate (PR) of less than 1 (one) case per 10,000 (Ten thousand) population) in 2005. But in some districts and blocks the PR is still more than 1 (one) per 10000 population mostly in the Tea Garden containing upper Assam districts. Most of the cases detected in last year and current FY are MB cases with high % of Grade II disability cases. So there is necessity of continuous case detection activities in the entire district under NLEP.

The National Strategic Plan (NSP) and Roadmap 2023-27 was rolled out on 30th January, 2023 for moving towards achieving interruption of transmission of Leprosy in India. This in line with WHO Roadmap for Neglected Tropical Diseases 2021-2030 and Global Strategy 2021-2030.

Vision : Leprosy Free India with zero infection and disease, zero disability, zero stigma & discrimination.

Goal : Accelerate towards achieving interruption of Leprosy Transmission in India.

Specific objectives:

1. Strengthen leadership, commitment and partnerships
2. Acceleration of Case Detection
3. Provision of Quality Services
4. Enhanced measures for Prevention of Disease, Disabilities, Stigma, Discrimination and Violation of Human Rights
5. Digitalization of Surveillance Systems.

National Strategic Plan and Roadmap for Leprosy 2023-2027



The main objectives under NLEP :

1. Elimination of Leprosy i.e. Prevalence of less than 1 case per 10,000 population in all the blocks / districts of the State.
2. Early case detection without deformity.
3. Strengthen Disability Prevention & Medical (DPMR) of Persons affected by Leprosy.
4. Reduction in the level of Stigma associated with Leprosy.

PROGRAMME STRATEGY :

To achieve the objectives of the plan, the main strategies to be followed are:

- Strengthening of integration for leprosy services through General Health Care system.
- Early detection & complete treatment of new leprosy cases.
- Carrying out household contact survey for early detection of hidden cases like FLC, ACD & RS.
- Involvement of Accredited Social Health Activist (ASHA) in the Leprosy suspects, follow-up & supervision for completion of treatment of Leprosy cases in time.
- Strengthening of Disability Prevention & Medical Rehabilitation (DPMR) services.
- Information, Education & Communication (IEC) & IPC activities in the community to improve self-reporting to Primary Health Centre (PHC) and reduction of stigma.
- Intensive monitoring and supervision at all levels.

To make NLEP planning compliant with NHM guidelines, the following 8 results are approved to be achieved:

1. Improved early case detection.
2. Improve case management.
3. Stigma reduction.
4. Development of Leprosy expertise sustained.
5. Research supported evidence base programme practices.
6. Monitoring Supervision and Evaluation system improved.
7. Increased participation of Persons affected by Leprosy in Society.
8. Involvement of community in accepting persons affected by leprosy.
9. Programme management ensured.

PROGRAMME COMPONENTS :

The following components are under NLEP :-

- Case Detection and Management – Active Case Detection & Regular Surveillance LCDC, ACD&RS, FLC, PEP etc.
- Disability Prevention and Medical Rehabilitation – RCS, MCR &Self Care Kits distribution to the patients etc.
- Information, Education and Communication (IEC) including Behavior Change Communication (BCC)
- Capacity building
- Programme Management
- PPP activity.

➤ **Situation Analysis: -**

Assam has achieved the goal of elimination of Leprosy (i.e. Prevalence Rate of less than 1 (one) case per 10,000 (Ten thousand) population) in 2005. But in some districts and blocks the PR is still more than 1 (one) per 10000 population mostly in the Tea Garden containing upper Assam districts. Most of the cases detected in last year and current FY are MB cases with high % of Grade II disability cases. So there is necessity of continuous case detection activities in the entire district under NLEP.

1. Availability of free adequate and effective MDT.
2. Good coordination with administration.
3. Regular review meeting chaired at District level and State Level.
4. Integration of NLEP with NHM make fund available to carry out activities.
5. Guidelines are available.

WEAKNESS:

1. No designated Medical Officer under NLEP district-wise.
2. DPMR services are poor :
 - a. There are no local facilities in the State to procure and provide MCR footwear to the needy Leprosy patients. It is to be procured from outside of the State which is time consuming.
 - b. Nonexistence of expert surgeons for Re-Constructive Surgery (RCS).

OPPORTUNITIES:

1. Integration with NHM leading to better monitoring and supervision.
2. Integration with RBSK, RKSK for Screening of School children and adolescents.
3. Support of ILEP and WHO.
4. Valuable support from all the Medical colleges including AIIMS, Sangsari, Kamrup.
5. Involvement of PALs/PRI members/Community Volunteers in Leprosy case detection.

THREATS:

1. Deployment of NLEP staff to other activities.
2. Floods during monsoon.

Sl. No.: 69 :: Case Detection and management

SI No. 69.1 : Active Case Detection & Regular Surveillance (ACD & RS).

With a view to widen the coverage of population screening for early case detection and to strengthen the active surveillance under NLEP, it is imperative to carry out active case search on a regular basis round the year and not occasionally in a campaign mode. The guidelines explicated in the paragraphs hereafter shall help the States/UTs plan their active case detection activities in such a manner that no one from the vulnerable population is left out of screening and active surveillance for leprosy.

Under the guidance of Joint Secretary (Lep), GoI, Central Leprosy Division has finalized a the New Guideline for Active Case Detection and Regular Surveillance (ACD&RS) and received the same from Govt. of India on 27th July 2020.

In the guideline, Active Case Detection and Regular Surveillance (ACD&RS) to be done in village & urban pocket once or twice (one round=6 month) as per criteria.

Frequency and criteria for screening rounds :

Frequency of screening (rounds)

The entire population of the given village/urban pocket in a low endemic block should be screened within 12 months so as to cover the entire population in a year. For areas in high endemic Blocks, there would be two rounds of screening in such a manner that the entire population is screened twice a year. The gap between the two rounds of screening of an individual would be six months in the areas where two rounds of screening are to be conducted. In other words, every person residing in a low endemic area would be Screened once a year, and in high endemic areas twice a year.

Criteria of Focused Active Case Detection activities as per NSP Road map

Active Case Detection activities carried out based on prioritization :-

Prioritization of Districts

Districts are classified into 4 prioritization categories on the basis of annual new case detection rate per 100000 population (ANCDR) and percentage of Grade-II Disability cases among new cases (G2D%)

The 4 categories are -

- Highest Priority Districts,**
- High Priority Districts,**
- Moderate Priority Districts**
- Low Priority districts**

The prioritization has been done for deciding in which districts which set of activities are required, at what frequency

Steps followed in **district segregation** are as follows.

Step 1.

- i. **Index value of ANCDR** for each district : (Average ANCDR of districts – ANCDR of the particular district).
- ii. **Index value of G2D %** of the district : (Average G2D % - G2D% of the particular district)

Step 2.

- Each district is given a score ranging between 0-2.
- If index value of ANCDR is <0, the score assigned = 0
if index ANCDR is >0, score assigned = 2
- If index G2D % is <0, score assigned = 1
If index G2D % is >0, score assigned = 2

Step 3.

- Score calculated in step-2 are added to get a **composite score** for each districts which ranges from **1 – 4**

Step 4

- Districts with composite score = 1 are the **Highest priority districts**.
- Districts with composite score = 2 are the **High priority districts**.
- Districts with composite score = 3 are the **Moderate priority districts**.
- Districts with composite score = 4 are the **Low priority districts**.

SL No. 69.2 -Prevention of Disability (PoD) Camp.

To reduce the further disability of Grade II disability cases, Prevention of Disability (PoD) camp is much essential. So, the State plans to conduct PoD camps @2 camps per high case load district and @1 camp in the rest of the districts.

Budget approved for PoDCamps for FY 2024-26:

One PoD Camp = 20 PALs having Gr. I &Gr.II disability.

1. Patients Transportation costs = Rs.6000/- per Camp.

2. Miscellaneous expenditure for arrangement of the camp = Rs.4000/- per camp.

SL No. 69.9 – Leprosy case Detection Campaign (LCDC)

Leprosy Case Detection Campaign (LCDC) :The main objective of LCDC is to bring out the hidden Leprosy cases, increase voluntary reporting and create awareness among public about the signs & symptoms of Leprosy and also about its full curability in modern times.

In the FY 2022-23 and 2023-24 till July, 2023, it has been observed that high % of MB cases and G2D are being detected which indicates that there are undetected hidden cases in the community. The G2D % is 12.9% in the year 2022-23 and 10.26% in the year 2023-24 till July, 2023 among new cases in regular case detection activities.

Moreover, it has been noticed with concerned that even the districts blocks with sporadic cases has shown occurrence of Grade I Grade II disability cases in middle and lower Assam having fewer number of tea gardens.

This FY i.e. 2023-24 is going to be conducted in all the districts of Assam as per suggestion of MD, NHM, Assam and approval of SPIP 2023-24. The LCDC is going to be conducted in 2 (two) phases in the month of October – November, 2023.

In view of the occurrence of G2D in 17 districts and high incidence MB new cases in almost all the districts, It would be better if LCDC could be conducted in 2 or 3 consecutive years to screen the whole population and detect the entire hidden cases in the community. As we are acting as per NSP and Roadmap 2023-27 for achieving zero transmission goals, yearly LCDC for 2-3 years will accelerate case detection activities so that the State of Assam can achieve the goal along with the country.

For these concerns, MD NHM, Assam convened a meeting on 4th July, 2023 to discuss how to eliminate leprosy from Assam as per the GOI's goal of achieving zero transmission of leprosy by the year 2027. In the minutes of the meeting, the need for conducting LCDC for three consecutive years was highlighted and the SPO, NLEP Assam was instructed to propose LCDC action plan with budget in upcoming PIP proposals for another two consecutive years i.e. 2024-25 & 2025-26.

Base on resolution taken in meeting, the LCDC proposal for next two consecutive years is prepared and it has been approved accordingly.

SI. No. 72.1 - Training & Capacity Building

Training needs :-

- As there is no designated Medical Officer in Leprosy, the MOs, District Leprosy Cells frequently changed. So, capacity building of MOs, DLC is essential as they are the Nodal Officer of NLEP in the district level.
- Trainings on leprosy will be required for Medical Officers working in the urban areas both under Govt. and Non-Governmental institutions regularly.
- In addition to the above, other Medical Officers under BPHC will also require training. This re-orientation is required to keep the diagnostic and management skills upto date. This will help in improving the quality of services provided by the PHCs. Doctors as well as pharmacist of Tea Gardens need to be trained up, as most of the Leprosy cases are detected from Tea Garden areas.
- Training for Health Supervisors (Male & Female) and Health Workers (Male & Female) will be carried out regularly every year.
- As most of the Leprosy cases detected with Grade II deformity from Tea garden Areas in Assam, hence training on Leprosy of the Staff of the Tea gardens is very much necessary.
- Training for newly appointed Non-Medical Assistant (NMA) is approved.

Sl. No. 72.2 - IEC / BCC under NLEP

Objectives of IEC :-

- To develop communication material vis-à-vis the target audiences and deliver effectively.
- To complement and support the detection and treatment services being provided free of cost through the General Health Care System which is available all Govt. Health Institution.
- To remove stigma associated with leprosy and prevent discrimination against leprosy affected persons.
- To specifically cover beneficiaries, health providers, influencers and the masses.

IEC under NLEP has been decentralized to the States/ UTs who will make their own plan and implement same. Central Leprosy Division will provide broad guidelines with allotted budget to the States/ UTs, who will have the flexibility to allocate cost to districts as per local **Priority areas** and **Target groups** to be attended through –

- Mass Media –TV, Radio and press in local languages.
- Outdoor Media - Hoardings, Bus panels, Wall paintings, posters, Rallies including Banners.
- Rural Media - IPC meetings, School talks/quiz, Folk media, Exhibitions and Health Melas.
- Advocacy - Meetings with ZilaParishad, MahilaMandals, NGOs etc.

Interpersonal Communication (IPC) through the health staff involving communities, Panchayat leaders and NGO through advocacy workshops will remain the focused approach.

Priority Areas:

- Low literacy rates in general with low female literacy rates in particular.
- Tribal population
- High Case Load districts
- Urban areas with problem of migration.

Target groups:

- Women from the areas where literacy rate is low.
- School children
- Population groups residing in remote inaccessible areas and tribal population.
- Migratory population.
- People living in urban slums.

• Anti-Leprosy Fortnight termed as 'SPARSH LEPROSY AWARENESS CAMPAIGN' (SLAC):

SL No. 72.4 -NGO Scheme under NLEP.

Medical rehabilitation is one of the main components of DPMR and RCS is accorded priority. RCS with referral facility is considered as the highest level of referral centre (tertiary care services) in leprosy. Though GMCH was identified as RCS Centre, very few RCS cases done due to Lack of Technical staff/Leprosy trained Physiotherapist and inadequate beds. So, most of the cases are operated at Borgang Catholic Hospital (NGO) with surgeon from outside in collaboration with ILEP/AIFO.

Under the Scheme 1 (C), Borgang Catholic Hospital, Sonitpur is working since last 6 years covering the patients almost all the districts.

In addition to that, the following services are taken –

- Cases of difficult-to-diagnose leprosy and in need of confirmation including relapse patients
- Cases with Grade 2 disability requiring medical or surgical treatment,
- Management of all forms of lepra reaction
- Cases with adverse effects of MDT
- Cases requiring MCR footwear, crutches, wheel chair, other materials etc.
- Laboratory facilities with skin-slit smear and all other routine tests,
- Counseling to patient and his family on RCS, social aspects, etc.

SL No. 72.11 - Special Screening in Tea Gardens under Innovation

Whether it is new/ongoing activity: New Activity (Innovative)

Justification :

It has been observed that the tea gardens in Assam vary in sizes and population and the tea garden population usually exceeds the allotted populations to an ASHA. Most of the tea gardens are allotted to one ASHA which she cannot cover in her usual case search activities. **On the other hand, in Assam, most of the new leprosy cases including Grade I & Grade II disability cases are being reported from tea gardens.** Even, LCDC activity also cannot cover the whole tea garden population for unavailability of total tea garden community at home during the campaign days due to their working schedule. **Therefore, it becomes necessary that special screening activities have to be carried out in the tea gardens to screen each individual member of the tea garden community so that no case is missed and transmission of leprosy infection can be stopped.**

In view of the GOI's goal of achieving zero transmission of leprosy by the year 2027, it is very much necessary that the tea garden populations are surveyed thoroughly in a special plan mode so that no hidden cases remain undetected.

For the special case detection activities, ASHAs, FLWs and Supervisors are to be deputed to the tea gardens during the activity in order to screen the total population in each tea garden in a year.

Task Forces are being formed in tea gardens including the Tea Garden Management, Tea Garden Hospitals and NLEP team to facilitate case detection activities and IEC campaigns in the tea gardens of Assam. These task forces will be very much useful in the special case detection activity.

An action plan to be prepared by the districts for the activity as follows :

1. A meeting with the Tea Garden Management / Tea Garden Hospital will be held for preparation of the activity. A Task Force will be formed in each tea garden for facilitating awareness and participation of the tea garden community during the activity.
2. A Search Team in the line of LCDC activity comprising the local ASHA & a Male FLW / Volunteer will be formed for each tea garden. (The district can plan according to population of the Tea Garden as per convenience).
3. The total population of the tea garden community must be covered under the activity.
4. The duration of the activity will be as per population of the tea garden i.e. 30 - 45 days.
5. Awareness meeting and IEC / BCC activities will be conducted within one week before the activity.
6. After completion of the activity, each member of the search team will get incentives of Rs.1000/- per member.
7. For logistic expenditure Rs. 1000/- per Tea garden is approved for the activity.
8. For Monitoring & Supervision of the activity, Budget approved for State HQ Rs.2.00 Lac & Rs.1.17 Lac for Districts (As per comments from Central Leprosy Division, Gol comments)
