### As NIDDCP has no district cell. So, all the activities will be done at state level except ASHA incentive.

- 1. Goitre survey (FMR Code. 10.2.2): -
  - Goitre survey will be conducted in Six nos. of district. Out of six districts 3 nos. of districts (which are near by Guwahati) will be done by Community Medicine department of GMCH and another 3 nos. of districts will be done by state IDD Cell.
  - **2.** The selected districts for survey are Kamrup(R), Darrang, Morigaon, Dibrugarh, Sivasagar & Tinsukia. The approve fund is Rs. 3.00 lakhs.
  - 3. As per GoI guideline @Rs. 50,000/- per districts can be spent for Goitre survey.
  - 4. The total nos. of samples per districts for clinical observation of Goitre should be 2700 nos. (Age group 6- 12 years). The salt sample should be collected 540 nos. The urine sample should collected 270 nos.
  - 5. Selection of samples must be done by Population proportionate to Size(PPS ) methods.

6.Collected salt and urine samples must be submitted to State IDD cell for testing.
