PREFACE

National Iodine Deficiency Disorders Control Programme

lodine deficiency disorders impact "refers to all of the ill effects of iodine deficiency in a population, which can be prevented by ensuring that the population has an adequate intake of lodine". The spectrum of lodine deficiency is not only Goitre but it might result in physical and mental retardation. It affects people of all ages, sexes and different socio economic status. It could also result in still birth, abortion, deaf-mutism, dwarfism, squint, cretinism, goitre of all ages, neuromotor defects, etc (Govt. of India's guideline for NIDDCP). The consumption of adequate lodised salt can prevent and eliminate lodine Deficiency Disorders.

Objectives: To make aware the people about use of adequate iodised salt and ensure the 100% consumption of adequate iodised salt and 100 % elimination of IDD in Assam.

Key priority area:-

- 1. House to house salt testing by ASHA in 14 nos. of IDD endemic districts.
- 2. The several awareness programme will be conducted on occasion of Global IDD Prevention day , 2022.
 - 3. Goitre survey/resurvey.
- 4. Monthly collection of urine and salt samples from all districts and testing of the collected samples in State IDD monitoring Lab.
 - 1. The district has to follow the guideline strictly for payment of ASHA incentive and reporting. Report and payment should be proportionate and must be booked the expenditure only in allotted FMR Code. RCH-8/ SI. No. 62.1- An amount of Rs. 25/- per ASHA per month has to be given against 50 nos. of salt samples testing per month. The incentive has to be paid to ASHA after submission of salt testing report by ASHA. RBSK District Coordinator has to be coordinated with DME & DCM for payment and reporting. Report and FMR should be reached to State IDD Cell on or before 7th of every month.(niddcp.assam@gmail.com).
 - 2. For Tally sheets (reporting format) we have allotted @Rs. 20,000/- for 14 IDD endemic districts.
 - 3. Under FMR Code. RCH-8/ SI. No. 62.4 Each districts has to be submitted 25 nos. of urines samples and 25 nos. of salt samples per month to State IDD monitoring Laboratory, Directorate of Health Services, Assam. Each district has one trained lab technician. The districts those who don't have trained lab technician may send Lab tech to State IDD monitoring lab for training on the collection of urine samples. The cost of collection and submission of samples to





State IDD monitoring lab will be borne from programme management fund of district health society.

4. Global IDD Prevention Day is celebrated in every year on 21st October. An amount of @Rs. 20,000/- per districts for 34 nos. districts. Which is approved for celebration of Global IDD Prevention Day in 2024-25 & 2025-26 RoP. The DME will be the responsible person to carry out the activities in the districts. A report with photograph have to be submitted after completion of the work. Additional amount of @Rs. 20,000/- given to 14(fourteen) nos. of IDD endemic districts for salt testing format(Tally sheets). Expenditure should be booked in the FMR Code. RCH-8 SI. No. 62.5.
