Minutes of SISC meeting on Family planning performance State held on 22nd December, 2021 at Board Room, NHM Office.

At the outset of the meeting SPO Family Planning gave a brief introduction on the progress and overall Family planning performance of State and District wise Family planning service performance since last two years.

The meeting was convened with following agenda

- Claims pertaining to failure, complication and deaths following sterilization operations.
- Family planning Performance
- Performance of the Non-performing empanelled LS Surgeon.

Following were the major areas for discussion and decision:

1. A total of 62 claims were received for the year 2021-22.

The death claim received was from Nagaon district which was received in 2021-22 although the death case occurred in 2020-21.

was observed that the performance of the Female sterilization has reduced as compared to previous years.

- 3. It was decided in the Meeting that post partum sterilization should be conducted by every Gynecologist after the Caesarian Section itself as there is a less chance of failure during this period. Director Health Service gave his view that special training is not required to perform PPS as the Gynecologists learns it during their Post graduation period .Performing PPS should be made mandatory for each Gynecologist. It was also decided in the meeting to send the report of LS Failure cases to the respective surgeon confidentially as they do not get any information regarding their failure from the district. It was informed that an in house meeting was already conducted on 13th Dec, 2021 at NHM state HQ with the LS surgeons having high failure rates to discuss the various factors leading to failures.
- 4. As the LS failure cases are considerable every year, it was decided to provide Refresher training for the LS Surgeons. The Refresher training will be organized in GMCH. Dr. P. Das, HoD, Department of Obstretrics and Gynaecology has been given the responsibility to organize the training at GMCH Batch wise with max 5 (Five) L.S Surgeon per batch. It was also decided that L.S Surgeon with high numbers of failure cases must undergo with the Refresher training of Laparoscopic Sterilization.
- 5. It has been observed that many of the trained surgeons are not performing Laparoscopic Sterilization Surgery in the District despite of having facility at the district. It was decided that the surgeons who have been trained for Female sterilization and are Non performing are to be retrained via refresher training on LS.
- 6. To increase the rate of PPIUCD and PPS, counseling should be given more importance. It was decided to give more focus to Hospital with high delivery rate, especially for the mothers after their
 2nd delivery. The client for family planning services post partum needs to be counseled at every opportunity starting from the Antenatal check up, in delivery room and also in the post natal period.
- 7. ED NHM instructed to do a comparative analysis of total performance of district regarding NSV, LS, PPS, IUCD and other family planning services for last 2 years.

The meeting ended with Vote of thanks from the chair
