- 2. Due to non availability of Boyle's apparatus at Amguri CHC the Superintendent of Sivasagar Civil Hospital, Joysagar is requested to provide a Boyle's apparatus (old) to Amguri CHC which is not used at Sivasagar Civil Hospital.
- 3. The Committee will visit Operation Theatre of Doomordolong Tea Estate Hospital for Lap and NSV operation and to be submitted details report in the district.
- 4. The Committee will develop a SOP for Laparoscopic & NSV operation and circulate to all the Institution and also asked to follow up the guideline of Lap sterilization properly.
  - 5. The Committee will visit and monitor of Operation Theatre before the Lap sterilization camp.
- 6. Due to shortage of Lap & NSV surgeon it is proposed that at least 2 nos of surgeon to be trained in the state level.
- 7. The Committee also discussed about the death case of Aroti Urang, 28 yrs, Old Towkak Charaideo district and the application approved for compensation of claims to submit to MD, NHM for the
