- All the beneficiaries who has done their female and male sterilization has to issue the sterilization certificate after stipulated period of pregnancy and semen test and DISC members are too ensured for the same.
- An overview of total performance, failure, complications, death and claim has been discussed by the Joint Director of Health services, Tinsukia.
