- Updating of Empanelment of all family planning service delivery categories was done by Joint Director of Health services, Tinsukia and accordingly a notification will issued.
- DFPC has updated the information regarding Tinsukia Dist also recognized as MPV (Mission Parivar Vikas) Dist with all the District of Assam and with this connection we have also celebrated WPD in July and January in each financial year.
- Regarding reorganization of Tinsukia is also MPV Dist Jt. DHS has emphasized all the FP methods likely temporary as well as permanent methods to expedited in the community level.
- Jt. DHS urge to all to promote Inj. Antra (MPA) in Tinsukia Civil Hospital as well as the PHC, CHC level and accordingly suggest to complete the Inj. Contraceptive to SC level for rolled out.


