- The Joint Director of Health Services, Tinsukia gave much emphasis on awareness meeting for motivating male participation for family planning services.
- In the regards of clearance of beneficiary compensation money (both LS & NSV) through PFMS Jt. DHS, Tinsukia suggest to DFPC that consultation with account officials and ensured that as soon as possible beneficiary compensation money has to be transferred into their accounts those who has completed sterilization services.
- It has been observed that the performance of temporary methods under Tinsukia District is not so up to the mark especially in terms of IUCD, PPIUCD, PAIUCD and Injectbale Antara. So Jt. DHS, Tinsukia urge the SDM & HO of each block has to uplift the temporary methods seriously
- It is to be ensured that each health institutions have to keep the adequate no of family planning articles (IUCD 380 A, IUCD 375, OCP, CC, Chhaya under Antara Programme).
- FP coordinator updated the status of performance for family planning especially WPD & WVD performance has been shared and he was happy to informed the panel that Tinsukia Dist has secured 1st position in in both female sterilization (LS, Minilap, PPS) & male sterilization (NSV) in State level..
- The meeting was ended with vote of thanks for the chair.
