This is to inform you that in reply to the showcase notices issued vide this office letters under Ref. 4(a & b) above culminating in the final notice under Ref. 5 above, you have furnished a commitment made in non-judicial stamp paper on 10/07/2019 to supply the items of insulin vials against the purchase orders under Ref. 3 (a, b &c) above at the hospitals on or before 31<sup>st</sup> of July 2019 onwards. Your above commitment was received in this office on 19/07/2019.

It is stated that in spite of your stated commitment to start delivery of the items from 31/07/2019 onwards as required as per terms & conditions of the contract agreement/ purchase orders, you have failed to make any delivery till date.

Rather, you have sent a mail at 01:33 AM of 1<sup>st</sup> August 2019 informing despatch of items against order from Mumbai which were expected to be available in our hospital soon.


Since your assumed delivery did not obviously fulfil the contractual obligations required before making any delivery, you were informed by mail at 1:45 a.m. of 1<sup>st</sup> August 2019 to ensure fulfilment of Despatch Clearance Certificate and other requirement as per contract agreement.

Your further response has been received from you nor any delivery against your alleged despatch of items as intimated vide your mail dated 1<sup>st</sup> August 2019 has taken place till date.

It goes without saying that your failure to supply the essential drug items against the purchase orders and as per your commitment has effected the treatment of poor patients at Govt. Health facilities of the State leading to increase out of pocket expenditure.

In view of the above and after considering the facts and circumstances of the matter, it has been decided that as per Clause No. 16 "Supply Condition"- Pt. No. I-iii "DELIVERY OF PRODUCTS" of the referred tender (at pt. 1 above), your company i.e M/S Wockhardt Ltd is hereby debarred from any further tender of NHM, Assam for period of 1 year (from the date of intimation) for the products viz, (1). Insulin Intermediate Acting (NPH) Insulin (Injection 40 IU/ml), (2). Insulin (Soluble) (Injection 40 IU/ml) and (3). Premix Insulin 30:70 Injection (Regular: NPH) (Injection 40 IU/ml).

The rate contract (under Ref. 2 above) is hereby cancelled forthwith.
