SQAC, a body for the policy decision and directions, will be responsible for all QA initatives, its success and shortcomings. The primary role of the committee at the State level will be to provide overall guidance, mentoring and monitoring of QA effort in the districts.

The committee will meet once in a six month to monitor the following:

- 1. To develop and implement the Quality Assurance policy and guideline for the state.
- 2. Ensuring attainment of the standard for quality of care by public health facilities.
- 3. Mentoring the State / District level unit.
- 4. Periodic review of the program.
- Review and adjudicate compensation of claim.
- 6. Review key performance indicator of facilities.
- 7. Support Quality improvement process
- 8. Update Reporting mechanism
