## 1. Eligibility Criteria:

- a. Registered APWD (Electrical) Class I-(A)/ I(B)/ I(C)/ Class II / CPWD/ APDCL registered Contractor/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking
- b. Contractors having completed works in any one year during last five years 90% of proposed value of work & atleast one similar nature of completed work value not less than 30% of the proposed project cost.
- c. In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed External electrification works in Sub-Centre on earlier occasion.
- d. The contractor who was earlier allotted any NRHM works by PWD(B), Assam or by NRHM and could not complete the work in all respect <u>in time</u> will not be <u>ELIGIBLE</u> to participate in the bidding process.
- e. The contractor and to whom extension of time was granted from NRHM imposing penalty will also be not **ELIGIBLE** to participate in the bidding process.
- f. The intended bidders are asked to verify the locations/ Sub-Centres for the work prior to quoting their rates.
- 2. Cost of tender document should be drawn in favour of **State Health Society, Assam,** payable at **Guwahati** in the form of Pay Order/Demand Draft.
- 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of Bank Guarantee/FDR/CDR and drawn in favour of the **State Health Society, Assam,** payable at **Guwahati**.
- 4. Date for issuing of Bid Document: 15-10-2012 to 16-10-2012 during working hours.
- 5. Last date and time of submission of Bid: 19-10-2012 at 14-00 hrs
  - a. The bids will be opened at 14.30 hrs of the same day as mentioned above.
  - b. In case, if any Bandh/Holiday falls in any sequence, the sequence will be held in the next working day.
