- c. In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Hospital related Building works on earlier occasion.
- d. The contractor who was earlier allotted any NRHM works and could not complete the work in all respect **in time** will not be **ELIGIBLE** to participate in the bidding process.
- e. The contractor & to whom extension of time was granted from NRHM imposing penalty will also not be **ELIGIBLE** to participate in the bidding process.
- 2. Cost of tender document should be drawn in favour of **State Health Society, Assam,** payable at **Guwahati** in the form of Pay Order/Demand Draft.
- 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of Bank Guarantee/ FDR/CDR and drawn in favour of the **State Health Society, Assam,** payable at **Guwahati**.
