#### <u>DETAILED NOTICE INVITING EXPRESSIONS OF INTEREST (EOI) FOR SETTING UP 5</u> KW SOLAR POWER PLANTS IN HEALTH INSTITUTIONS (SCs) IN ASSAM

#### 1) BACKGROUND:

The National Rural Health Mission has been launched to carry out necessary architectural correction in the basic health care delivery system. The Mission adopts a synergistic approach by relating health to determinants of good health viz. segments of nutrition, sanitation, hygiene and safe drinking water. It also aims at mainstreaming the Indian systems of medicine to facilitate health care. The Plan of Action includes increasing public expenditure on health, reducing regional imbalance in health infrastructure, pooling resources, integration of organizational structures, optimization of health manpower, decentralization and district management of health programmes, community participation and ownership of assets, induction of management and financial personnel into district health system, and operationalizing community health centers into functional hospitals meeting Indian Public Health Standards in each Block of the Country. The Goal of the Mission is to improve the availability of and access to quality health care by people, especially for those residing in rural areas, the poor, women and children.

#### 2) INVITATION FOR "EXPRESSION OF INTEREST":

NRHM Assam invites "Expressions of Interest" from reputed agencies having experience of establishing solar power plants under programs of Jawaharlal Nehru National Solar Mission (JNNSM), for setting up 5 KW Solar Power Plants at various health institutions in Assam. The following 10 locations have been selected for the purpose.

- 01) Bormukoli SC under Solamara BPHC in the district of Jorhat.
- 02) Goraimari SC under Manikpur BPHC in the district of Bongaigaon.
- 03) Bengirvita SC under Gazarikandi BPHC in the district of Dhubri.
- 04) Khupatia SC under Gazarikandi BPHC in the district of Dhubri.
- 05) Rajmita SC under Lakhipur BPHC in the district of Goalpara.
- 06) Tarangapur SC under Lakhipur BPHC in the district of Goalpara.
- 07) Simulbari SC under Lakhipur BPHC in the district of Goalpara.
- 08) Dekachang SC under Nagarbera BPHC in the district of Kamrup (R).
- 09) Daowaguri SC under Kochugaon BPHC in the district of Kokrajhar.
- 10) Bhotgoan SC under Balajan BPHC in the district of Kokrajhar.

"Expressions of Interest" along with prescribed documents should be sent by post/courier service so as to reach the place of submission (indicated below) on or before 2:00 PM of 04/01/2013.

- a) Agencies having prior experience of setting up solar power plants under various programs sponsored by Government of India, Ministry of New & Renewable Energy. The agencies should provide details of at least two successful installations in the last five years, in any part of the country. (Documentary evidence of execution of solar power projects should be furnished.)
- b) Agencies having competent personnel with rich experience/credentials (agencies to provide details of such personnel).
- c) Agencies having adequate infrastructure for the purpose of timely execution of solar power projects (agencies to provide full details of infrastructure facilities / equipments at their disposal).
- d) Agencies having sound financial standing (agencies to furnish Annual Turn Over Statement for the last 3 financial years i.e. 2009 2010, 2010 2011 & 2011 -2012 along with statement of concurrent commitment in the specified format at **Annexure A** certified by the Auditor/ Chartered Accountant).

#### 4) ADDITIONAL QUALIFICATIONS:

Agencies may indicate if they fulfill the following conditions:

- (i) Experience of executing solar power projects in the North East Region of the country.
- (ii) Experience of executing solar power projects for Government Health Institutions, Government Organizations, Public Sector Undertakings and international bodies like WHO & UNICEF.

#### 5) EVALUATION / SELECTION PROCEDURE:

Evaluation / selection shall be carried out in the following stages:-

- (i) Agencies with sound financial background and reliable track record will be short-listed based on the responses against the notice inviting "expressions of interest".
- (ii) The short listed agencies will be required to give presentation on (a) experience of executing solar power projects in the country, (b) technical details including bill of materials, sourcing of equipments, installation of system and time frame for setting up a 5 KW solar power plant (c) commercial details including methodology of financing solar power projects under programs sponsored by the Government, budgetary estimate of costs etc. Based on the presentations, the list of agencies may be pruned further.
- (iii) The final short listed agencies will be required to submit their bids in two parts technical bid & price bid. Price bids of the agencies found to be technically acceptable shall be opened in presence of bidders.
