Sub. : Requisitioning of Gauhati University medical staff.


Sir,

In view of ongoing COVID-19 pandemic and the increase in COVID-19 cases, it is urgently required to augment the number of Health Care Workers at the disposal of Health & Family Welfare Department.

Presently, the Gauhati University is closed and hence some of the Medical Staff / Health Care Workers deployed in medical unit/ hospital of Gauhati University can be utilized for COVID related duties, leaving a skeletal staff at the Unit, for any exigency. The list of medical/ health care staff of the Gauhati University Medical Unit which can be deployed for COVID duties, as provided by Director of Health Services, Assam is given at Annexure-I.

In this connection, you are requested to immediately requisition the services of the medical staff as at Annexure-I, under Section 65 of Disaster Management Act, 2005 and place them at the disposal of Mission Director, National Health Mission, Assam who will suitably deploy the staff in health facilities in and around Guwahati, on a temporary basis.


