#### ORDER

In continuation of Health & Family Welfare Department's earlier order No.HLB.47/2021/23 dated 19/02/2021 (Annexure-I), the following arrangements are hereby made for the medical treatment of any Central Armed Police Forces (CAPF)/ State Armed Police (SAP)/ India Reserve (IR)/ Security Personnel/ any other personnel deployed in election duties:

- 1. The treatment for any injury or sickness for any personnel engaged in election duties in any hospital shall be free of cost/ cashless for the patient.
- Depending on the severity of the illness/ injury, the treatment will first be provided at the nearest District hospital or Medical College Hospital as per need. However, the patient will be referred from District Hospital to Medical College Hospital or from Medical College Hospital to another Government or private sector tertiary care hospital for further treatment, if required.
- 3. In case of a hospital under the Health & Family Welfare Department, the hospital will temporarily bear, from Hospital management Society or other source of fund that is available, any expenditure that may be required for ensuring cashless treatment. For reimbursement of the expenditure, the Superintendent of the concerned Government hospital will submit details of the bills and bank account to Director of Medical Education or Director of Health Services, as the case may be, for verification, who will submit these to the State Nodal Health Officer for election, Health & Family Welfare Department for onward submission of the verified bills to Election Department along with recommendation for reimbursement of the fund to the concerned hospital account directly by the Election Department.
- 4. In case of any referral made by Medical College Hospital to another hospital outside the Health & Family Welfare Department, a report shall immediately be submitted by Superintendent of the Medical College Hospital to State Nodal Health Officer for election, Health & Family Welfare Department, Director of Medical Education and Shri K Talukdar, Deputy CEO, Atal Amrit Yojana Society, in the format given at Annexure-II. Deputy CEO, Atal Amrit Yojana Society will communicate in writing to the referral hospital to ensure cashless treatment for the referred patient as per Government norms, and also inform that the expenditure in this connection shall be borne by the Election Department, Government of Assam. The referral hospital will submit the bills to Deputy CEO, who will in turn forward these to Director of Health Services cum Member Secretary; Assam State Council for Clinical Establishments for verification. The verified bills will be submitted by Director of Health Services to the State Nodal Health Officer for election, Health & Family Welfare Department for onward submission of the bills to Election Department along with recommendation for reimbursement of the fund to the concerned hospital directly by the Election Department.



This order will come into force with immediate effect.

#### **ORDER**

In pursuance of broad guidelines for conduct of elections during COVID-19 pandemic issued by Election Commission of India, the following medical arrangements are made in connection with the conduct of the ensuing election to the Assam Legislative Assembly:

- In case, any Central Armed Police Forces (CAPF) personnel deputed for election related duties in Assam tests positive for COVID-19, his treatment in any COVID-19 hospital under Health & Family Welfare Department, Government of Assam shall be free of cost.
- 2. In case, any CAPF personnel who has been tested COVID-19 positive, develops complications, the required treatment shall be carried out in any suitable hospital under Health & Family Welfare Department free of cost.
- 3. During the process of conduct of the election, 10% of beds in all hospitals under Health & Family Welfare Department shall be kept reserved for the personnel engaged in election related duties, including CAPF, for providing any treatment that may be required. Corresponding medical facilities, as required, will be earmarked accordingly.
- 4. In case of any violent incident/ attack involving polling personnel/ police personnel/ CAPF, or any other person engaged in election duty, the District Election Officer and Superintendent of Police shall take all measures to ensure proper treatment to the injured. There shall be a minute to minute monitoring of evacuation and treatment process from the district control room. Deputy Commissioner and Joint Director of Health Services in a district will ensure that advance arrangements for such injured personnel and those who fall sick while deployed for election duties are kept in place in order to avoid delays at the last moment.
- Joint Director of Health Services in a district will pro-actively monitor treatment of any personnel involved in election duties, under the supervision of Deputy Commissioner.

This order will come into force with immediate effect.
