**ORDER**

The following norms shall be applicable in case of medical arrangements for any central Armed Police Forces (CAPF)/ State Armed Police (SAP)/ India Reserve (IR)/ security personnel/ personnel deployed in election duties as laid down in this Department's earlier order No.HLB.47/2021/61 dated 16/03/2021;

1. **Referral Hospital:** Any hospital, Government or Private, which is empanelled under Assam Medical Attendance Rules, 2008/ Atal Amrit Abhiyan Society (AAAS)/ Pradhan Mantri Jan Arogya Yojana (PMJAY)/ Central Government Health Scheme (CGHS) is deemed to be referral hospital to which Superintendent of a medical college hospital under Health & Family Welfare Department may refer patients. Any referral to outside the State should be made only with full justification, if such treatment is not available within the State in any hospital.
2. **Rates of medical treatment:** The hospitals as mentioned at (1) above will carry out treatment of referral patients at rates not exceeding CGHS rates and the payments against the medical treatment will be made to the hospitals by the Election Department, Government of Assam, at such rates.
3. **Authorized official for communicating with referral hospitals:** Shri Kamaljit Talukdar, ACS, Deputy Secretary & Deputy CEO, AAAS, Assam, is hereby authorized by the Health & Family Welfare Department to make all communications with the aforesaid referral hospitals to finalize the tie-ups/ arrangements with the hospitals accordingly. He shall also communicate to the hospital in case any treatment is required by any personnel, including security personnel, connected with election duties, as per the framework of the aforesaid Government orders. He shall utilize, for this purpose, the human & other resources at the disposal of AAAS as required by him.

This order will come into force with immediate effect.
