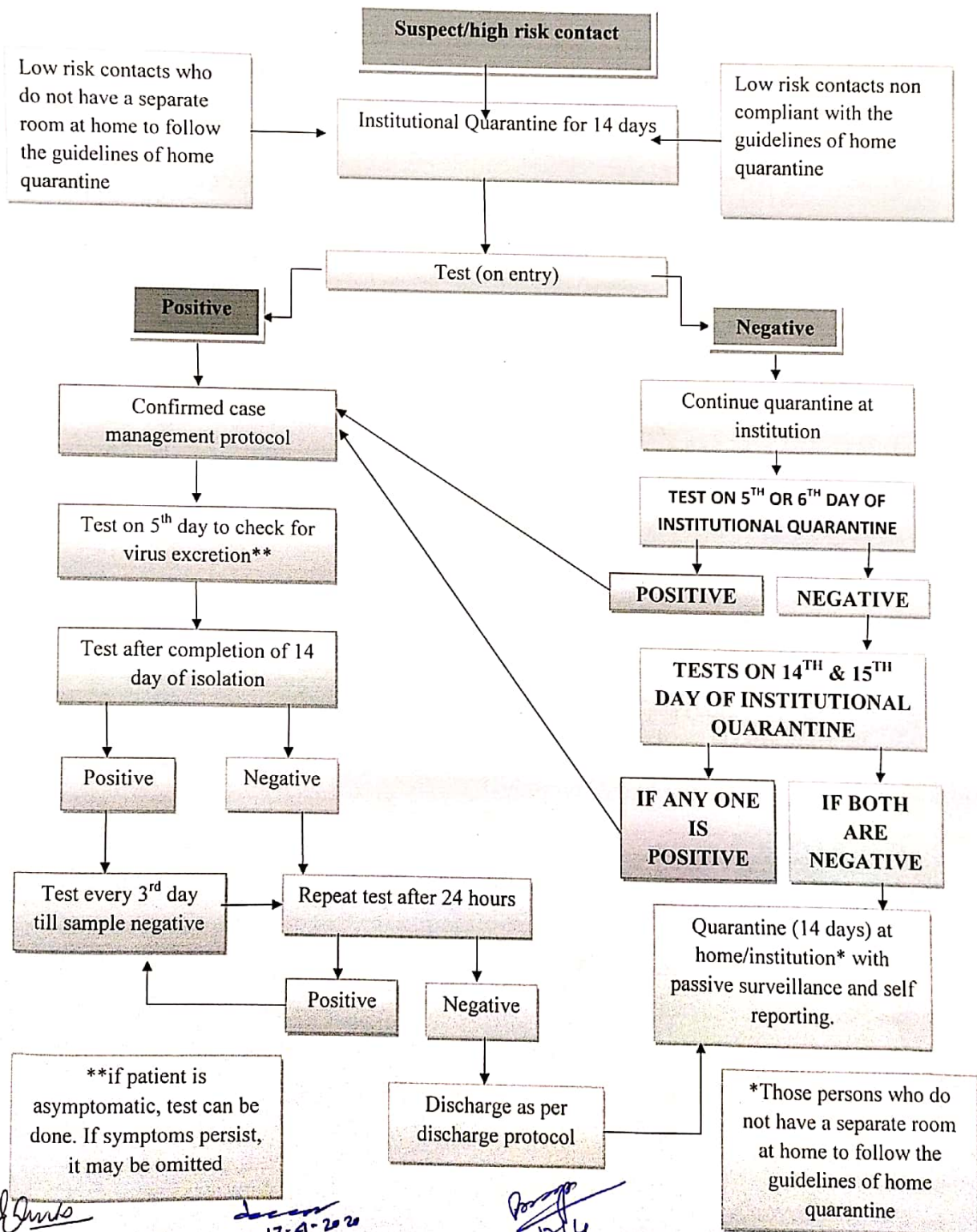

**CORRIGENDUM**

**SOP FOR DISCHARGE FROM ISOLATION WARDS/INSTITUTIONAL QUARANTINE**

In continuation of earlier orders in respect of the Assam COVID-19 Discharge Board vide No. HLA 270/2020/102 dated 5/4/2020; additional SOP for release from quarantine and protocol to be followed vide HLA.270/2020/116 dated 08/04/2020; a corrigendum is issued hereby to be followed along with *the earlier SOP for discharge from isolation wards* vide No.HLA.270/2020/130 dated 10/04/2020.

**PROCESS TO BE FOLLOWED FOR DISCHARGE FROM ISOLATION WARDS/ INSTITUTIONAL QUARANTINE**



If a person tests negative at the time of entry to the institutional quarantine, he/she shall be tested again on **5<sup>th</sup> or 6<sup>th</sup> day** of Institutional Quarantine.

If he is found negative, he/she shall be tested again **twice on day 14<sup>th</sup> and 15<sup>th</sup>** of Institutional Quarantine. If any of the results is positive then the cases managed as per confirmed case management protocol for COVID-19 and if both tests are negative then the case is sent to 14 days House Quarantine under Passive Surveillance.
